what is the Indie Training Fund?

- A charity to fund and deliver training for the UK independent TV and digital media production sectors
- Established, funded and run by Member Companies (big and small from around the UK)
- ITF provides Member Companies with in-house training and consultancy, plus short courses around the UK
- ITF collaborates with Pact on training content and priorities
- Major ITF grants are distributed by *Skillset* to subsidise freelance training
- Runs ITF Freelancer scheme for individual freelancers who wish to develop their skills through training

Access to skilled freelancers

- Much of ITF funding is distributed by the Skillset TV Freelance Fund – TVFF (matched by broadcaster funding)
- TVFF funds new entrant and continuing professional development training e.g. 01 zero-one, Cyfle, DV Talent, Regional Screen Agencies, Scottish Screen, Top TV, VET, etc.

Political influence – championing our industry

- Skillset, the industry's Sector Skills Council, receives core funding from ITF (matched by Government and other sectors in Skillset footprint)
- Indies influence Government training policy through Skillset
- ITF Member Companies publicly seen as leading investors in training – helping them to attract top talent...

cost of Company Membership

- **0.25% of annual UK production turnover**
(recommended donation)
 - Capped at £100,000 a year charitable contribution
 - Based on average or previous year's production turnover
 - Paid monthly or quarterly in arrears
 - ITF contributions are tax deductible

- **£250 for new companies / turnovers below £200K**
(recommended donation)
